

## **Aquatic Invasive Species Fines under the *Preset Fines and Offence Descriptions Regulation***

In response to the spread of aquatic invasive species, legislative amendments were made in 2015 to protect Manitoba's waters, creating numerous new offences.

The *Preset Fines and Offence Descriptions Regulation* has been amended, effective October 17, 2018, allowing enforcement officers to issue tickets using short-form offence descriptions and preset fine amounts for the following AIS-related offences.
