Mr. SCHULER – To urge the Provincial Government to not surrender nor weaken any personal health privacy rights when signing a new Canada Health Transfer agreement; to not create a Digital ID nor accept any requirements for the creation of a Digital ID tied to healthcare funding; and to not share any personal medical information with the Federal Government or third parties as this information is protected under the Personal Health Information Act (PHIA) and sharing any personal health information would be in violation of that Act.
